Only 4 per cent of its resources are invested in small and medium enterprises, which suffer a shortage of finance. For DFID, financial performance is the principal indicator of CDC's development impact, but this information is not sufficient to assess CDC's effect on poverty reduction and not enough is done to measure compliance with ethical investment principles. The level and nature of CDC executive remuneration are also relevant to business efficiency and management incentives. The Chief Executive's remuneration increased from £383,000 in 2003 to £970,000 in 2007, reflecting in part CDC's exceptional financial performance but pay arrangements place too much emphasis on financial performance and too little on success in reducing poverty.
