Secondly and more specifically, as every text depicting a social system takes a position, I study Burney's criticism of the social world sketched in Cecilia. What is criticised? How systematic is this criticism? It was often claimed how realistically Burney wrote and how accurate her description of the society in Cecilia appeared to its readers. Modern historiography, however, describes 18th Century England as a society without class consciousness and thus also without class conflict. Awareness of class and status was, according to this view, very different to that in industrial society, and had a different impact on the members of the earlier society. The middle class, to which the author also belonged, so the historiographical narrative argues, was only then beginning to emerge and assert itself. This is a difference between the discourse in Cecilia and the narrative of how 18th Century society was represented from the second half of the 20th Century onwards. The third aim of this paper will deal with this discrepancy. The trend started in the north: until the 1560s, composers of Cecilian motets were mostly active in northern France and the Netherlands. Romance Object Clitics Oct 01 2020 This book offers an empirical and theoretical exploration of the development of object clitic pronouns in the Romance languages, drawing on data from Latin, medieval vernaculars, modern Romance languages, and lesser-known dialects. Diego Pescarini examines phonological, morphological, and especially syntactic aspects of Romance object clitics, using the findings to reconstruct their evolution from Latin to Romance and to model clitic placement in modern Romance languages. On the theoretical side, the volume engages with previous accounts of clitics, particularly in generative theory. It challenges the received idea that cliticization resulted from a form of syntactic deficiency; instead, it proposes that clitics resulted from the feature endowment of discourse features, which initially caused freezing of certain pronominal forms and then - through reanalysis - their successive incorporation to verbal hosts. This approach leads to a revision of earlier analyses of well-known phenomena such as interpolation, climbing, and enclisis/proclisis alternations, and to new approaches to issues including V2 syntax, scrambling, and stylistic fronting, among many others.

Verb Second in Medieval Romance Jan 24 2020 This volume provides the first book-length study of the controversial topic of Verb Second and related properties in a range of Medieval Romance varieties.
